Over time, a large collection of screenshots, messages, images, clips, and inside jokes surrounding Histieroo began to build up.

This archive, known as **The Histieroo Files**, documents that lore.

BACKGROUND

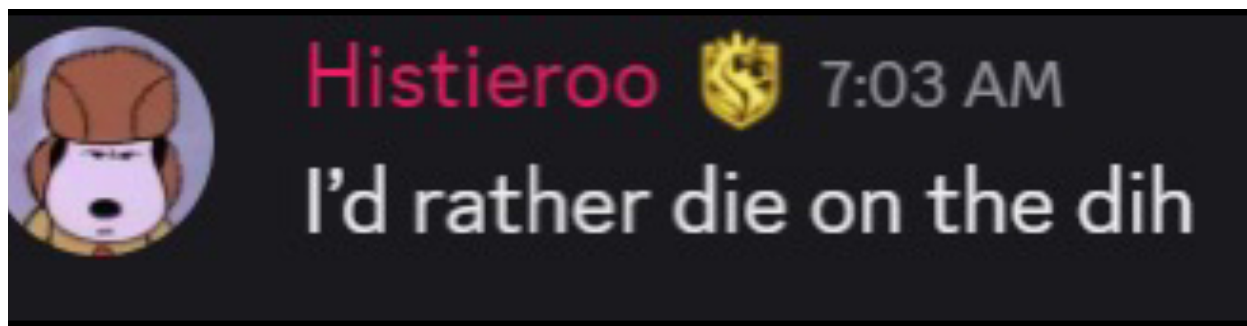
Histieroo first became known after starting the Football Fusion league **TGFL**, also known as the **Taco Gaming Football League**.

He started the league mainly to show his love for football... **or so we thought**.

As TGFL continued, screenshots began to surface showing Histieroo making inappropriate comments and jokes in the chat.

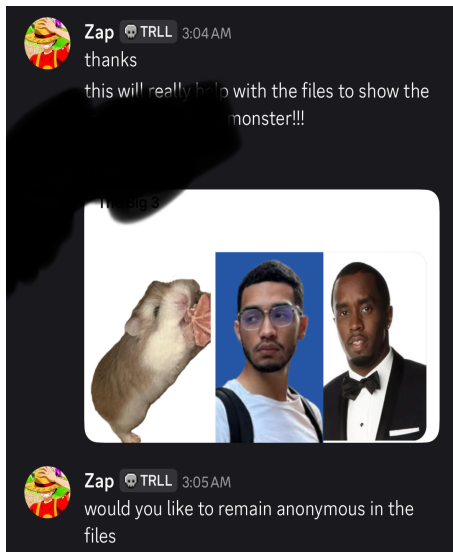

One of the first images appeared to show Histieroo alongside Diddy at a party.

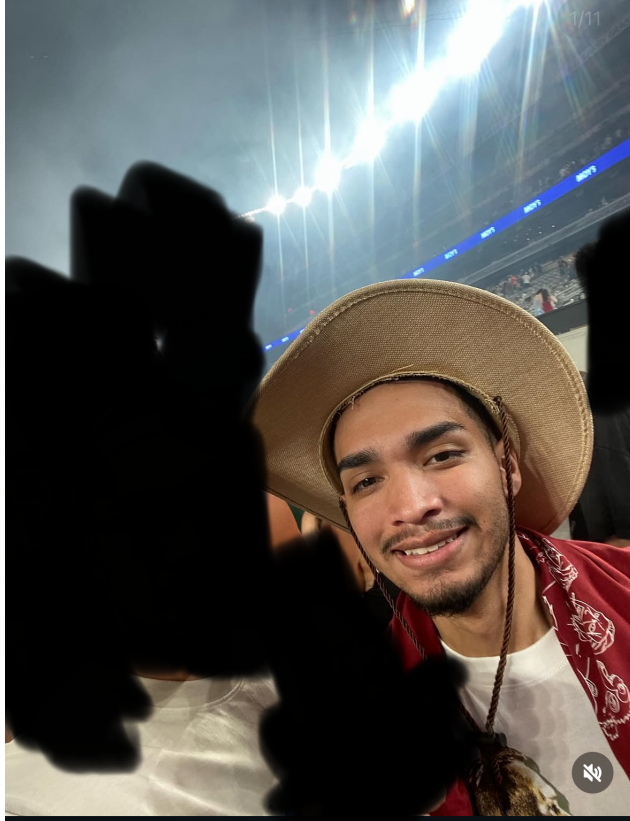


This image quickly became part of what would later be known as “**The Diddy Era.**”

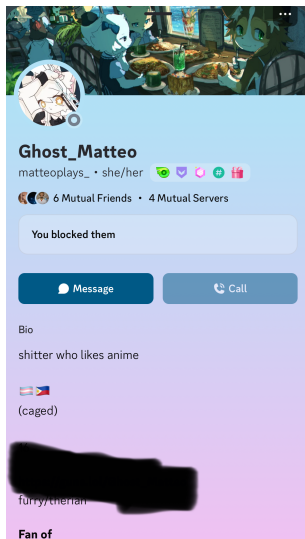
Of course, Histieroo wasn't the only person involved in the history of TGFL.

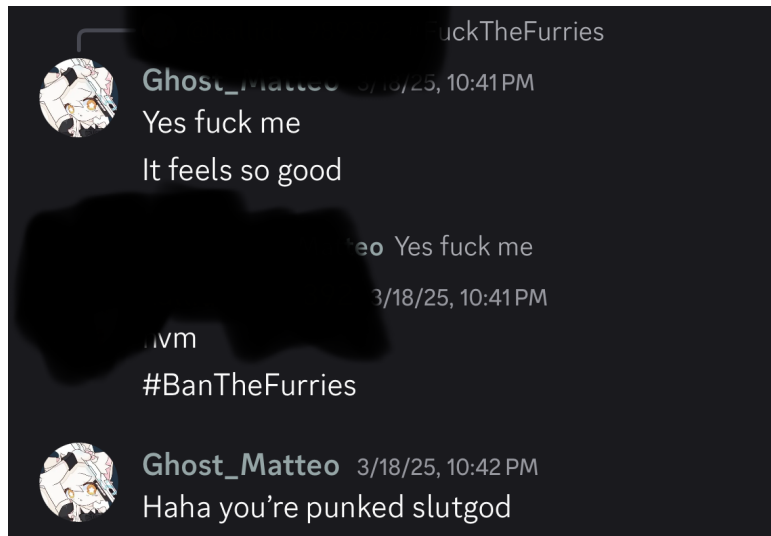

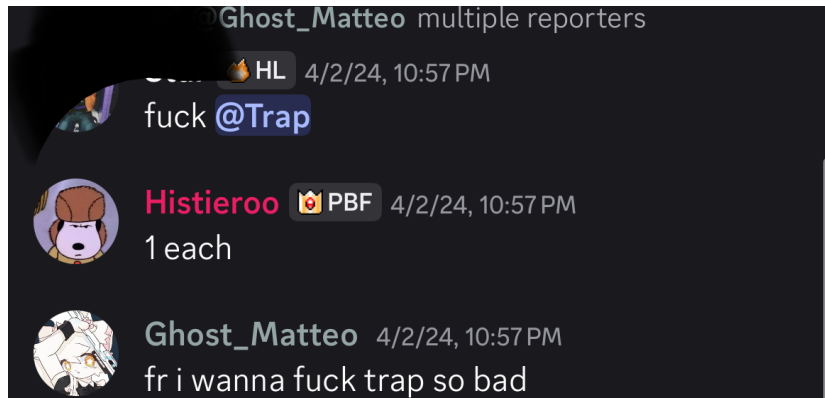
